Positive response for Covid-19 covers, but lack of reinsurance support is worrying

In health segment, 'reinsurance depends fully on insurer's discretion, risk profile'

The recently-launched standalone health covers for Covid-19 have seen tremendous response from customers but reinsurance support continues to be a challenge for most insurers.

"There is no reinsurance support for the product across the industry. It is completely dependent on the insurer's discretion and risk profile," said an executive with a private sector general insurance company, adding that, many people have gone ahead and purchased the policies.

Another insurer said discussions are being held with

re-insurers for possible support but it has been difficult till now, this has impacted pricing for many firms.

"Overall, health is retail business without much reinsurance support. The same goes for the Covid-19 covers launched," noted an executive with a reinsurance firm.

Products launched

To make Covid-19 treatment more affordable for people, the Insurance Regulatory and Development Authority of India (IRDAI) had asked insurers to come out with two standard health insurance products. which were launched on July 10. The Corona Kavach is an indem-

"There is not much reinsurance available for health insurance. It is mostly written on retention basis, so reinsurance industry is also trying to understand the experience on health insurance," said PC Kandpal, Managing Director

not proved to be a disincentive for insurers from offering products.

He said the response to the two policies has been positive. The SBI General Insurance is also waiting for these to be made available on group platforms for a larger audience.

S Prakash, Managing Director, Star Health and Allied Insurance, however, added that reinsurance support is available for both the policies. "Reinsurance support is available for Covid-19 policies; it depends on how the insurers are placed in pricing and servicing the policy," he noted.

Star Health and Allied Insurance has sold over 1.5 lakh Corona Kavach policies and nearly 25,000 Corona Rakshak policies.

US immigration agency's furlough plan for staff may delay issue of visa

Wait time for work visas could be over a year, according to reports

VENKATESH GANESH Mumbai, August 16

The US Citizenship and Immigration Services' (USCIS) plan to furlough two-third of its 20,000 employees from August 30 is expected to impact Indian techies planning to go to the US.

This could dramatically increase the waiting timefor people with pending immigration petitions and applications and is expected to delay work visas by over a year, according to reports.

The USCIS is the agency is tasked with providing citizenship, visas and greencards and is struggling to keep its operations running due to lack of budgets.

"Potential furloughs in the US could dramatically increase wait



times for people with pending immigration petitions and applications," said Sophie Alcorn, Attorney in Immigration and Nationality Law, State of California Board of Legal Specialization, Al-

According to the Migration Policy Institute, "For each month the US-CIS furlough lasts, 75,000 applications for various immigration benefits will not be processed."

US President Donald Trump had signed two proclamations in April and June that suspended green card processing and

banned the entry of non-immigrant workers such as H-1B visa holders into the US.

Growing backlog

However, even before the pandemic, the USCIS had a sizeable backlog. Currently, there is a backlog of almost 10 lakh foreign nationals and accompanying family members lawfully residing in the

In this backdrop, furloughs will significantly delay the process. "It is taking 8-12 months for them to process some H-1B cases, and if the processing times increase, the position could no longer be available," said Prashanthi Reddy, immigration lawyer from New York-based Law Offices of Prashanthi Reddy.

On August 14, it reopened the H-1B filing window and petitions can be filed from August 17 till November 16 in addition to the usual March-end filing for a total of another 85,000 visas.

Many novel Covid measures for monsoon session of RS

New Delhi, August 10

The Rajya Sabha is gearing for the monsoon session with the secretariat altering seating arrangements to ensure social distancing among members, officials, staff and visitors.

Four large-display screens in the chamber, another six small screens in the four galleries, audio consoles in the galleries, ultraviolet germicidal irradiation, audio-visual link for the two Houses, polycarbonate sheet separating the official gallery from the chamber of the House, have been made.

Unique arrangements

"All these arrangements mark the first-of-its-kind session to be held in compliance with the social distancing norm under the coronavirus induced restrictions. Using the chambers and

the galleries of both the Houses for holding the session being the major first of its kind in the history of Indian Parliament since 1952," a release from Rajya Sabha Chairman Venkaiah

Naidu's office said According to the new arrangements, chambers and galleries of both Rajya Sabha and Lok Sabha will be used for seating the members of the House.

Sixty members will be accommodated in the chamber and 51 in the galleries, leaving out the first row. The remaining 132 can sit in the Lok Sabha.

Prime Minister, Leaders of the House, Opposition and other parties will sit in the chamber including former prime ministers Manmohan Singh and HD Deve Gowda and some ministers. "Other ministers will be seated in the seats meant for the ruling party," the release added.

India's foreign exchange reserves have tripled in the Marchend to August 7 period vis-a-vis the year-ago period and continues to grow.

During this period, the reserves swelled by \$60.384 billion against \$17.701 billion in the year-ago period.

At this rate, in just the first five months of the current financial year, forex reserves will likely bulk up by as much as what was added in the whole of last financial year (FY20). In FY20, the reserves jumped by \$62.691 billion.

Low trade deficit, higher FDI The reserves touched a new re-

cord high of \$538.191 billion as on August 7, 2020.

India now holds the fourth

largest forex reserves in the

Madan Sabnavis, Chief Economist, CARE Ratings, opined that the forex reserves have jumped mainly due to the dip in the trade deficit and higher foreign direct investment (FDI) inflows

"Essentially, the trade deficit has come down, and FDI has gone up. Lower trade deficit also means lower current account deficit. That is the main reason why the forex reserves are going up," he said.

Sabnavis observed that the implication of the increase in reserves is strengthening of the currency based on fundamentals (balance of payments) and external factors (essentially, what is happening to the

Brickwork Ratings (BWR), in its report Drishtikone, attributed the sharp rise in forex re-

serves to jump in the price of gold, which accounts for 6 per cent of the total reserves.

Underscoring that forex reserves come with a cost, Sujan Hajra, Chief Economist, Anand Rathi Securities, in a report, cautioned: "While this (forex reserves) provides huge resilience to India's external sector position, with low (often less than 1 per cent) yield, the cost of holding high forex reserves is rising." This would make a pro-

gressive accumulation of forex reserves costly for the country, especially since the reserve levels are already high by all measures, he added.

Rupee strengthens

In the backdrop of dollar inflows and weakening of the greenback, strengthened from 75.60 to the dollar as on March 31, 2020 to 74.93 as on August 7, 2020.

Last week, the rupee closed a shade stronger at 74.90 on August 14 vis-a-vis previous weekend's close of 74.93.

According to the International Monetary Fund, forex reserves are held by a country in support of a range of objectives including to support and maintain confidence in the policies for monetary and exchange rate management, including the capacity to intervene in support of the national or union currency.

producers to commence the supply of fly ash in BOXN wagons covered with tarpaulin. The innovation will pave the way for efficient and safe transportation of large quantities of fly ash from the power plants to cement production units located at a distance," the statement added.

This is a significant development for the transportation of fly ash from a remote location to a consumption centre, enabling power plants to enhance utilisation of fly ash. It is possible with the availability of additional material loading avenues for the Indian Railways and accessibility of fly ash to the cement plants in an environment-friendly manner at a competitive price.

During 2019-20 fiscal, almost 44.33 million tonnes of flyash (73 per cent of the quantity generated) were utilised for various purposes, the statement said.

NTPC is also looking at new avenues of fly ash management such as fly ash based geopolymer road, use of bottom ash as replacement of fine aggregate (sand) in cement concrete. In addition to these, NTPC has plans to set up a fly ash classifier unit for export purposes.

Tyre-maker Balkrishna Industries' ₹1,000-cr expansion plan 'on track'

Chennai, August 16 Balkrishna Industries, the country's leading off-highway tyre manufacturer, has said that its ₹1,000-crore capacity expansion programme is on track. It has also identified a few focus areas for growth.

The company, which sells its products under BKT brand, is establishing a fully integrated facility at a capex of about ₹500 crore to replace the existing plant to enhance productivity.

Similarly, the company is setting up an ultra large-sized allsteel OTR (off-the-road) radial tyre unit with a capacity of 5,000 tonnes per annum at its Bhuj factory in Gujarat. This is reported to be the first of its kind plant in India. Also, the company is building a warehouse and mixing plant there. The estimated capex for these is

The above project is to take

advantage of the opportunity arising out of earthmover and mining tyres segment, where there is a shift from bias to radial tyres.

"Capex programmes of the company are broadly on track. The company is trying to complete the projects as per schedule, i.e., March 31, 2021, provided there is no further Covid-19 lockdown and unforeseen circumstances," the company management said during its communication to in-

vestors. The company said its Q1FY21 was a good quarter despite the impact of Covid-19. Sales in May and June were at 38,096 tonnes (51,034 tonnes in the first quarter last fiscal). The monthly run rate is gaining momentum and is visible in July and August.

As on June 30, it had cash and cash equivalents of ₹1,175 crore with no long-term debt.

JNPT dredging contract heads for litigation

India's biggest channel deepening work at Jawaharlal Nehru Port Trust (INPT) is heading for litigation with the team of Belgian and Dutch dredging contractors invoking arbitration to recover unpaid dues of ₹200 crore on the contract that was completed in

February 2019. INPT had hired a joint venture between Boskalis Smit India LLP and Jan De Nul Dredging India Pvt Ltd through a global tender in September 2017, to deepen the channel from 14 metres to 15 metres to allow bigger parcel size ships to dock.

The JV has written to JNPT to start arbitration for non-payment of ₹200 crore on the

dredging contract. The contractors have also made a claim for ₹130 crore as they were asked to change the scope of work, while the ₹1,966-crore contract was in progress by altering the dumping ground for dredged materials and for detention of dredgers, according to government sources in Delhi.

The payment of last three in-

voices worth ₹200 crore has been denied at the behest of the Shipping Ministry, though, multiple agencies including the National Institute of Oceanography, JNPT, Tata Consulting Engineers (the project management consultant), IIT-Chennai and an advisor to INPT had certified and endorsed the depth completion of the project.

The final payment has been held back on the pretext of some investigation to "discover flaws' in the contract, a government official said. Since the dredging work was completed, JNPT has received over 150 bigger parcel size ships, generating more revenue.

'Further investigation'

Before demitting office in April this year, the then Shipping Secretary Gopal Krishna recommended "further investigation" into the contract on suspicion that the project cost was "inflated" due to cartelisation by foreign dredging contractors who participated in the tender, among other issues.

JNPT officials declined to comment. Boskalis-Jan De Nul also de clined to comment.

New Delhi, August 16

Citing media reports in western press, the Opposition demanded a Joint Parliamentary Committee probe into the alleged nexus between the Sangh Parivar and social media platforms such as Facebook and WhatsApp.

Congress' former president Rahul Gandhi alleged that the BJF and the RSS control Facebook and WhatsApp in India. "They spread fake news and hatred through it and use it to influence the electorate. Finally, the American media has come out with the truth about Facebook," he

Senior Congress leader and spokesman Ajay Maken said that a reputed American newspaper had reported how hundreds of millions of Indians are controlled, divided and manipulated through fake news and hate speech propagated by the BJP through Facebook. "India's rich electoral democracy cannot be sacrificed at the altar of Facebook and WhatsApp. There must be a



serious Joint Parliamentary Committee to probe into these matters further," he told reporters at a press conference here on

He alleged that the social media platforms have interfered with the election process of the country. "What gave Facebook the guts and the gumption to intrude, interfere and intervene in the world's largest democratic exercise?" he said, and added that Facebook and WhatsApp control information, news and communication for hundreds of millions of Indians. 
