POLICY FOR DETERMINATION OF MATERIALITY OF EVENTS OR
INFORMATION

(In pursuance to Regulations 30 of SEBI (Listing Obligations and Disclosure Requirements Regulations, 2015)

Introduction

1. The Policy aims for disclosure of important and material events of the Company to the Stock Exchange where the equity shares of the Company are listed, in compliance with the provisions of the Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (hereinafter referred to as “Regulations”).
2. The Board, in its meeting held on January 30, 2016, approved this Policy and thereafter amended in its Board Meeting held on November 09, 2020, for determination of materiality of events or information and disclosure thereof to the Stock Exchange.
3. The policy shall be effective immediately.

Policy:

- 4(i) The Company shall disclose to the Stock Exchange all events or information as specified in Annexure-I.

Disclosure in respect of para 4 of Annexure-I is to be made within 30 minutes of the conclusion of the Board Meeting.

Disclosure in respect of other paras of Annexure –I are to be made within 24 hours from the occurrence of events or information.

In case there is any delay in filing the disclosure, the Company will provide necessary explanation for the delay.

- 4(ii) The Company, in respect of events mentioned in Annexure-II, will make the disclosure, assessing the materiality on the basis of following guidelines:
 - (a) The omission of an event or information, which is likely to result in discontinuity or alteration of event or information already available publicly; or
 - (b) The omission of an event or information is likely to result in significant market reaction if the said omission came to light at a later date;

4(iii) In case the guidelines mentioned in (a) and (b) of preceding paragraph are not applicable, the disclosure of various items will be made on the basis of following parameters:-

3	Capacity addition or product launch.	
4	Awarding, bagging/ receiving, amendment or termination of awarded/bagged orders/contracts not in the normal course of business.	In case the order is more than Rs. 200 crore.
5	Agreements (viz. loan agreement(s) (as a borrower) or any other agreement(s) which are binding and not in normal course of business) and revision(s) or amendment(s) or termination(s) thereof.	In case the agreement is for more than Rs. 200 crore.
6	Disruption of operations of any one or more units or division of the company due to natural calamity (earthquake, flood, fire etc.), force majeure or events such as strikes, lockouts etc.	10% of the gross revenue as per the Audited Consolidated Financial Results of the preceding year.
7	Effect(s) arising out of change in the regulatory framework applicable to the company.	
8	Litigation(s) / dispute(s) / regulatory action(s) with impact	
9	Fraud/defaults etc. by directors (other than key managerial personnel) or employees of listed entity.	Rs. 1 crore
10	Options to purchase securities including any ESOP/ESPS Scheme.	All
11	Giving of guarantees or indemnity or becoming a surety for any third party.	All guarantees of Rs. 10 crore and above (other than guarantees given for Subsidiary & Joint Venture Companies and guarantees in the normal course of business).
12	Granting, withdrawal, surrender, cancellation or suspension of key licenses or regulatory approvals.	10% of the gross revenue as per the Audited Consolidated Financial Results of the preceding year.

4(iv) In addition to above disclosure, The Company will also make disclosure on account of following:-

(A) Notification of following orders booked by the Company as and when these are booked:-

(a) Manufacturing Products – Orders of the value of Rs. 30 crores and above, and

(b) Projects – e.g. Boiler, EPC, FGD, Sugar Machinery (Noida Operations) – Orders of the value of Rs. 100 crores and above.

(B) Notification on account of any major development that is likely to have a material effect on the business i.e. emergence of new technologies, expiry of patents, any change of accounting policy that may have a significant impact on the accounts, etc.

4(v) Disclosure with regard to all material events or information relating to subsidiary companies will also be made. As provided in the Regulation, the materiality with regard to events of subsidiaries has to be seen with reference to Company and the basis will be same, as mentioned above, with regard to events relating to the Company.

3	<p>Revision in Rating(s).</p>
4	<p>Outcome of Meetings of the Board of Directors: The listed entity shall disclose to the Exchange(s), within 30 minutes of the closure of the meeting, held to consider the following:</p> <p style="padding-left: 40px;">(a) dividends and/or cash bonuses recommended or declared or the decision to pass any dividend and the date on which dividend shall be paid/dispatched; (b) any cancellation of dividend with reasons thereof; (c) the decision on buyback of securities; (d) the decision with respect to fund raising proposed to be undertaken; (e) increase in capital by issue of bonus shares through capitalization including the date on which such bonus shares shall be credited/ dispatched; (f) reissue of forfeited shares or securities, or the issue of shares or securities held in reserve for future issue or the creation in any form or manner of new shares or securities or any other rights, privileges or benefits to subscribe to; (g) short particulars of any other alterations of capital, including calls; (h) financial results; (i) decision on voluntary delisting by the company from stock exchange(s).</p>
